#### A. Conclusion of Corporate Insolvency Resolution Process

- 1) The Company Petition 3747/IB/2018 was admitted by the Hon'ble National Company Law Tribunal (Hon'ble Tribunal), Mumbai Bench, under Section 7 of the Insolvency and Bankruptcy Code 2016 (Code) for initiation of Corporate Insolvency Resolution Process (CIRP) of Sanghavi Exports International Pvt Ltd (Corporate Debtor) vide its Order dated 19<sup>th</sup> February 2019.
- 2) CoC, in their 9<sup>th</sup> meeting held on 13<sup>th</sup> November 2019 unanimously passed a resolution for liquidating the Corporate Debtor, accordingly, RP filed Liquidation Application MA No. 3955/2019 u/s 33 of the Code. The same was heard on various dates and on 15<sup>th</sup> December 2020, the Ld. Bench passed the Liquidation Order commencing the Liquidation Process of the Corporate Debtor.
- 3) The liquidator made a public announcement on 17<sup>th</sup> December 2020 in Form B of Schedule II as per Regulation 12 of Liquidation Regulations, 2016, towards calling for submission of claims from all the stakeholders. The advertisement (Form B) was published in Business Standard (All edition), Navshakti (Mumbai edition) and Sandesh (Gujarat edition) on 17th December 2020.
- 4) The Liquidator has processed and verified the claims based on the supporting documents / information provided by the stakeholder and thus is filing a list of stakeholders with the Hon'ble NCLT, Mumbai Bench, in line with Regulation 31 of IBBI (Liquidation Process) Regulations, 2016.
